# **Operation Round Up**

Cooperatives across the nation adhere to seven cooperative principles. These principles help guide decision making, from how the cooperative is operates to how the cooperative engages with local communities.

Concern for community is the seventh cooperative principle, and it is one everyone at Roughrider Electric Cooperative value. During Cooperative Month, which is celebrated in October, we are especially reminded of the important role of concern for community.

Electric cooperatives have a proud history of giving back. You may find Roughrider Electric present at events, such as county fairs, baseball games and other community gatherings.

But Roughrider Electric members help us give

back, too. Through our Operation Round Up program, members can round up their energy bills to the next dollar amount, and the extra change goes toward helping those in need, right here in the communities we serve.

# Operation Round Up giving in 2024

Operation Round Up has been in place for 22 years at Roughrider Electric. Twice a year, Roughrider Electric's Operation Round Up board members, who are also cooperative members, meet to review and distribute Operation Round Up funds to deserving recipients across our service area. In 2024, Roughrider Electric donated funds to 23 recipients, totaling \$38,785 going back to communities.

## **Center Community Pool**

The Center Community Pool is a community staple, as an indoor pool open year-round to provide a safe and fun place for community members. The Center Community Pool requested funds to help maintain the pool facility, including repairing cracks and repainting the base of the pool. The pool is home to exercise classes, school swim lessons, recreational use and the swim team, the Barracudas. The Operation Round Up funds will help ensure the pool can stay open for the community to utilize and enjoy.

"Being able to repair these issues will help us continue to provide a safe recreational place for community members," says Shandy Kraft, Center Community Pool Manager.

## **Dunn County Sheriff's Office**

In the heart of Dunn County is the Dunn County Sheriff's Office, which serves residents from Killdeer to Twin Buttes. Operation Round Up funds will be used to purchase stuffed dogs to be used in conjunction with the Dunn Country Sheriff's Office therapy dog, Finn. Deputies take Finn to visit schools, nursing homes, day cares and other places where people find peace in the presence of a therapy dog.

"For some people petting a dog can help take some stress away and feel a sense of calm and comfort" says Gary Kuhn, Dunn County Sheriff. "The stuffed animals will help serve as a comforting reminder to community residents in times of need."

Everyone enjoys Finn's visits and with the addition of stuffed toy dogs, they can help people around the county feel a sense of calm, even when Finn isn't there.

### **Gladstone Consolidated Fire District**

The Gladstone Consolidated Fire District serves approximately 1,500 residents from Stark and Dunn counties. Operation Round Up funds will be used to help purchase a tender tank fire truck. A tender tank fire truck is used to transport large amounts of water, foam and other solutions used to fight fires.

The updated tank truck will help the department increase firefighting capabilities to the people and communities we serve," says Terri Thiel, Gladstone Consolidated Fire District Board Secretary/Treasurer.

# Marketplace for Kids Inc.

Marketplace for Kids Inc. is an organization that provides educational experiences for students, including North Dakota. Marketplace for Kids Inc. hosts various education programs geared towards entrepreneurship, kids within a 60 miles radius are invited to an event free of charge to learn more

about the career opportunities available locally. An educational day was hosted in March at Dickinson State University (DSU). The educational day at DSU provided insight to kids on entrepreneurship and career choices from careers in the region.

"Our vision is for every student to receive entrepreneurship education and encouragement to become a lifelong partner in building stronger communities," says Robert Heitkamp, Marketplace for Kids executive director.

# LIHEAP is here to help

As autumn arrives, Roughrider Electric Cooperative members are faced with cooling temperatures, and even colder temperatures in the coming months. For some, anticipation of the winter months causes stress and anxiety, as they wonder how to make ends meet. Thankfully, there are programs to help members.

The Low Income Home Energy Assistance Program (LIHEAP) can help low-income and eligible individuals with assistance when it comes to heating and insulation costs in the winter. Through the N.D. Department of Human Services, human service zone offices and Community Options, individuals can be helped with a variety of services when it comes to home energy assistance, including heating.

#### Services offered

LIHEAP offers a variety of service assistance. Not only can the program help curb the costs of your heating and cooling bills, but it also helps households with weatherization services to make homes more energy efficient.

The assistance program may also help with the costs of furnace and chimney cleaning, emergency assistance and for devices to reduce energy costs. Homeowners and renters are eligible to apply for assistance.

## **Apply for LIHEAP**

LIHEAP eligible members can apply from Oct. 1 through May 31, 2025.

Upon applying for LIHEAP, an outreach specialist will enter your home and assist in gathering necessary documentation for the service. From there, an application will be sent to the state for review and the results will be provided within a few weeks.

# LiDAR being utilized

Roughrider Electric Cooperative is continuously looking for ways to improve the efficiency and effectiveness of its infrastructure for our members. Part of Roughrider Electric's 2024 work plan has been working with Innovative Energy Alliance (IEA) Cooperative's engineering department to use light detection and ranging technology (LiDAR) to patrol existing infrastructure.

IEA is a professional service cooperative owned by four electric distribution cooperatives in North Dakota, including Roughrider Electric.

## LiDAR technology


Each year, Roughrider Electric lines are patrolled overhead by helicopters who utilize this imagery technology with help from IEA's engineering department. IEA's engineering department examines the data provided and assesses how the current structures and power lines are preforming. From the reviewed data, it works on how the infrastructure can be improved to withstand future

energy loads, weather conditions and foliage growth.

LiDAR uses thermal imaging, which helps identify what may be working well for the cooperative's infrastructure and what may need some improvements in the future. LiDAR can help the team detect if the infrastructure can hold future energy load growth, power line ground clearance, spacing of power poles and identifies areas where trees may be encroaching on the lines.

The software uses various colors to highlight certain results such as red for spots that need more immediate attention. Utilizing this technology helps our operations crew and IEA's engineering department work together to ensure our infrastructure is performing efficiently to continue delivering reliable electric services to our members.

These technologies and partnerships allow Roughrider Electric to utilize state-of-the-art technology in our service territory at a reduced cost to our members to help us ensure safe, reliable electric services to you, our members.





# SAFETY STARTS WITH ME:

# Safety around substations

The electric grid is a complex system of power plants, transmission lines, substations and distribution lines that transmits electric power from the place where it's generated all the way to members at the end of the line.

When you are outdoors, keep a safe distance from power lines, substations and other electrical equipment Roughrider Electric Cooperative uses to send electricity to your home.

Roughrider Electric urges members to follow these tips to stay safe around substations:

- Keep a safe distance: Always maintain a safe distance from the substation. Substations are fenced for a reason, and only authorized personnel should enter. Teach children never to play near or attempt to enter a substation.
- Report suspicious activity: If you notice anyone
  in an unmarked vehicle or someone not wearing
  high-visibility clothing tampering with equipment
  or trying to enter the substation, report it to local
  authorities and Roughrider Electric immediately.
  Unauthorized access can be extremely dangerous.
- Stay clear during storms: After severe weather, avoid substations, since damaged power lines or equipment could pose significant risks. Wait for Roughrider Electric crews to assess and repair any damage.
- Do not touch downed power lines: If you see a downed power line near a substation, assume it is live and dangerous. Stay far away and contact emergency services and Roughrider Electric to report it.



"Substations are crucial in ensuring reliable power to our members," says Dion Gefre, a journeyman lineworker. "Keeping in mind the risks they pose when outdoors helps members take a part in ensuring electric services can continue to flow to homes and businesses in our community."
